CONDITIONS OF ENTRY

1. The event will be run according to the Speedway New Zealand General Rules and Regulations.
2. All drivers must hold a current SNZ Inc. Licence and all vehicles must comply with the current Speedway New Zealand Rule book and supplementary regulations.
3. **Noise level of 95dba** will be enforced as measured on the track infield.
4. **Electronic Lapscoreing will be used.** Lapscoreing will be by way of the Dorian Date-1tm. Timing/Scoring system. The official transmitter for Electronic Lapscoreing is Dorian Date-1 TX8000tm.
Transmitters and One-Way Receivers to be working
Vehicles without a transmitter will not be permitted to race.
Palmerston North Speedway does not provide transmitters.
5. Smoking is prohibited in the dummy grid area at all times.
6. All entry forms must be accompanied by a track clearance.
7. The Promoter reserves the right to issue **temporary numbers** to avoid duplication. Competitors will be advised of any such change to their racing number.
8. The promoter reserves the right to alter the format and closing date after consultation with officials, if deemed necessary. You will be notified of any such changes.
9. **Technical Inspections** – Please pay attention to Rules E2-3-1 to E2-3-5.
10. Sponsors advertising transfers will be affixed on each car.
11. Telephone entries will be accepted prior to written entry. Entries close **Wednesday 18th November 2020.**
12. In the event of a rainout, the Promoter reserves the right to hold the event on the next most opportune day and time.
13. **Alcoholic beverages** must not be consumed in the Pits. The bar in the Club Rooms will be open to drivers, friends and families at the end of racing.

NOTE: You cannot get more than 2 adults in on a family pass.

Race Format - Qualifying and Finals

Dependent on number of entries, entrants will be divided into equal groups with a maximum of 30 cars per group with a draw and reverse to decide the top qualifiers. Each qualifying race will be 12 laps. Finals races will be 15 laps. The highest points deemed to be the winner.

Qualifying -

Two Groups. Top **fourteen** point's scorers from each group plus the two place getters from a repechage race.

Three Groups. Top **nine** point's scorers from each group plus the first three place getters from a repechage race.

In the event of a tie on points per group the tied vehicles (from that group) will be decided by a toss of a coin.

Repechage race will be the next 30 highest point's scorers.

Finals –

Once qualifying is completed and the top 30 cars have been found there will be a further second tier Championship made up in order of qualifying points. i.e. After the Repechage drivers have been found the next six or eight (depending on entries) out of each group plus the next two highest points scorers.

Top 30 cars will then compete in three 15 lap races for points, with the top point's scorer being declared the “King of the Arena Stockcar” Champion.

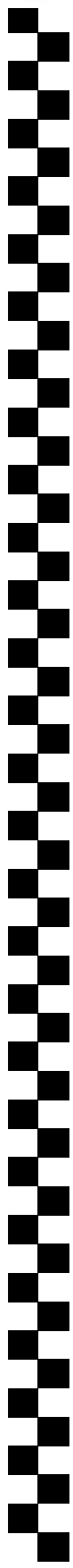
