

# **NEW ZEALAND SPRINTCAR GRAND PRIX**

#### Conditions of Entry

- 1. The event will be run according to the Speedway New Zealand Inc General Rules and Regulations. All drivers must hold a current SNZ Inc Licence and all vehicles must comply with the current Speedway New Zealand Rule Book and supplementary regulations.
- 2. The noise level of 95dba will be enforced.
- 3. Electronic lap scoring will be used. Lap scoring will be by way of the mylaps-1 timing system. Transmitters and one-way race radios to be working.
- 4. The Promoter reserves the right to issue temporary numbers to avoid duplication.
- 5. Email entries will be accepted by <u>info@wsspeedway.com</u> or PO Box 25-934, St Heliers, Auckland 1071.
- 6. In the event of a rain out or postponement for any reason the event will be scheduled for Sunday 29<sup>th</sup> November 2020. However, the Promoter reserves the right to hold the event on the next most opportune day and time.
- 7. In the event that you have forwarded an entry form and you discover you cannot attend you must notify the Promoter of your inability to honour this contract.
- 8. The Promoter reserves the right to alter the format to an SNZ approved format.

#### Format

- 1. As per SNZ Rule M4-23.
- 2. Qualifying (dependent on number of entries).
- 3. Elimination heats and repechage will be held to find 20 finalists. Races will be 12 laps. The top 16 will qualify, with remaining competitors contesting a repechage. The first 4 will complete the feature grid.
- 4. Twenty finalists will contest a 25-lap final. The highest point scorer will have the choice of starting position on the front row. The winner will be crowned the Daltons Sprintcar Grand Prix Champion.
- 5. Any points or grid ties will be decided by coin toss.
- 6. Vehicle checking from 3.00pm to 5.00pm in Western Springs pit area. Note: Rules E2-3-1 to E2-3-5.
- 7. Driver's briefing and grid draw 5.00pm sharp.
- 8. Racing starts at 6.00pm.
- 9. Admission entered drivers will be given 3 gate refunds via direct credit the week following the event.
